Federal law requires all online contributors to confirm that the following statements are true and accurate. If you cannot confirm each statement, you are not eligible to contribute to Brian Moore for Senate Florida Committee. Unchecked statements will result in your donation not being accepted.

If that amount is collected and Brian Moore secures a place on the Florida ballot, contributions over this filing requirement will be transferred to his election campaign.

Contribution Guidelines:

General Guidelines

- Brian Moore for US Senate Florida does not accept contributions from any political action committee (PAC). Contributions are not tax deductible.

- The maximum contribution is \$2000 per individual for the general election.
- Federal law requires political committees to use our best efforts to collect and report the name, mailing address, occupation, and name of employer for each individual whose contributions exceed \$200 in a calendar year.

Joint Contributions (Spouses & Partners)

- Spouses and partners may each contribute up to \$2000 for the primary election of \$4000 per couple, even if only one spouse or partner has income. However, only individual contributions can be made via our web form. If you wish to make a joint contribution online, please enter two separate charges, one for each individual. You can also contribute by mail.

Prohibited Contributions

We CANNOT accept:

- Contributions from corporations, labor organizations or National banks
- Contributions from federal contractors
- Contributions from foreign nationals. Foreign nationals are persons who are neither citizens of the United States nor lawfully admitted for permanent residence. "Green Card" holders are permitted to contribute.
- Contributions in the name of another. You may only contribute from your own personal funds (or the funds of your spouse/partner, in the case of a joint contribution).

- *Federal law prohibits contributions from corporations, labor organizations, National banks, federal contractors, and foreign nationals not admitted for permanent residence.*
- *Contributions must be from personal funds and not reimbursed by another person.*
